

# BYLAW NO. 2024-8

## REGULATE THE SPEED OF MOTOR VEHICLES

### A Bylaw of the Rural Municipality of Browning No. 34, in the Province of Saskatchewan, being a Bylaw to Regulate the Speed of Motor Vehicles

---

The Council of the Rural Municipality of Browning No. 34, in the Province of Saskatchewan, pursuant to Section 8 (1) (f) and Section 12 of *The Municipalities Act*, enacts as follows:

1. In this Bylaw:
  - a. **Motor vehicle** shall have the meaning ascribed to it by *The Highways and Transportation Act, 1997*.
  - b. **Public highway** shall have the meaning ascribed to it by *The Highways and Transportation Act, 1997*, but shall not include a provincial highway as designated pursuant to such Act.
2. No person shall operate a motor vehicle at a greater speed than forty (40) kilometers per hour within the hamlets of Steelman and Willmar, Saskatchewan.
3. No person shall operate a motor vehicle at a speed greater than sixty (60) kilometers per hour on the public highway described as follows:
  - a. That portion of Range Road 2070 located W of NW 7-4-6 W2M, W of SW 18-4-6 W2M, and W of SW 31-4-6 W2M.
  - b. That portion of Range Road 2064 E of SE 20-6-6 W2M.
  - c. That portion of Range Road 2052 E of SE & PT NE 15-4-5 W2M, and E of SE 27-4-5 W2M.
  - d. That portion of Range Road 2054 E of NE 20-4-5 W2M.
  - e. That portion of Township Road 60 N of NW 35-5-5 W2M.
  - f. That portion of Township Road 64 N of NW 19-6-5 W2M.All locations approximately six hundred (600) feet in front of residences.
4. No person shall operate a motor vehicle at a speed greater than ninety (90) kilometers per hour on the municipal roads as described as follows:
  - a. That portion of Grid 604 E of 16, 21, 28, 33-5-4 W2M, and E of 4, 9, 16, 21, 28, 33-6-4 W2M.


- b. Grid 605 E of 5, 8, 17, 20, 29, 32-4-6 W2M, E of 5, 8, 16, 21, 28, 33-5-6 W2M, E of 4, 9-6-6 W2M, N of 10, 11, 12-6-6 W2M, and E of 13, 24, 25, 36-6-6 W2M.
5. From April 1 to October 31 of each year, no person shall operate a motor vehicle, with a combined weight of vehicle and load over ten (10) tonnes, at a speed greater than sixty (60) kilometers per hour on the municipal roads described as follows:
  - a. That portion of Grid 604 E of 16, 21, 28, 33-5-4 W2M, and E of 4, 9, 16, 21, 28, 33-6-4 W2M.
  - b. Grid 605 E of 5, 8, 17, 20, 29, 32-4-6 W2M, E of 5, 8, 16, 21, 28, 33-5-6 W2M, E of 4, 9-6-6 W2M, N of 10, 11, 12-6-6 W2M, and E of 13, 24, 25, 36-6-6 W2M.
  - c. Council reserves the right to adjust the time period referred to in Section 5 by resolution of Council.
6. Signs indicating the maximum speed shall be erected at the commencement of the speed zone area and signs shall be erected showing the end of the speed zone area.
7. Any person who contravenes any of the provisions of this bylaw is guilty of an offence and liable on summary conviction to the penalties provided in the general penalty bylaw of the municipality.
8. Bylaw No. 2024-4 is hereby repealed.
9. This bylaw shall come into force and take effect upon final passing thereof.
